# **Fundraising**

Once the teams are formed, each player will receive a booklet of 10 tickets which they would have already prepaid for along with their registration fees. Players/parents can sell these tickets for \$10 each in order to be reimbursed for their pre-purchase of the \$100 booklet or just use them for themselves. The player/parents will keep this \$100 and turn in the tickets for the draw.

# Rep Fees

\$225 rep fee is payable after tryout decisions are made. This additional fee is due to rep teams having two practice ice times per week.

#### **Discounts**

\_\_\_\_

<u>Family Discount</u> - a multi player discount of \$100 is applicable for families registering more than one child. One child will pay the full registration amount. Each subsequent child will receive a \$100 discount off of their registration amount.

New to hockey discount - a 50% discount is offered to new players to CDMHA. This will be deducted after registration. The 50% discount is only applicable to the hockey fee amount and not the \$100 mandatory fundraising raffle ticket amount. eg. New U7 player's registration amount is \$425 consisting of \$100 in raffle tickets and \$325 in hockey fees. The total amount to be paid is  $$100 + (325 \times 50\% = 162.50)$  \$162.50 = \$262.50

Families joining CDMHA must have a parent or guardian complete a Respect in Sports online course.

NOTE: Only one discount can be applied per family.

## Payment Deadlines

50% of the total registration is due on **September 20**<sup>th.</sup>

#### Payment options:

Plan A - pay in full by September 20th.

Plan B - 50% of the remainder due October 20th and the remainder due November 20th.

All fees are due by November 20th unless other arrangements have been made with the Treasurer. Unpaid players will not be permitted on the ice after this date.
